CALL TO ORDER: The Village of Rushville Council was called into Special Session by President Pro Tem, Lillian Roderick at the Town Hall.

## **AGENDA:**

Resolution 2-2022 authorizing Mayor Paul Norby to submit and application to the Ohio Public Works Commission for a loan for paving Bremen Avenue and the alleys. Jennifer moved, and Steve seconded, to pass the Resolution. Motion passed, with Lillian abstaining.

Ordinance 3-2022 amending Appropriations for the Sewer Fund due to the ARPA Grant of \$16,248.65. Steve moved, and John seconded, to pass the Ordinance. Motion passed with Lillian abstaining. Cindy said she put in another 100 of the new floats and 3 more pumps as these are the supplies that Ned is requesting. She put the balance into Repairs and Maintenance as it appears that there will need to be repairs made to storm drains before we repave.

Ordinance 4-2022 amending Appropriations to the Street Fund due to the necessity of removing dead and dangerous trees at 8525 and 8533 Main St. Jennifer moved, and Steve seconded, to pass the Ordinance. Motion passed with Lillian abstaining.

Village Acceptance of Oak Leaf Lane- Jennifer reported that she had met with the Fairfield County Engineers office regarding the road. Their recommendation, given that there were no inspections during the various stages of construction, that Jeff be required to present Council with an Engineer's Study. Steve asked if everyone was in agreement that Council write a letter to Jeff that he has to provide the study, with core samples, attesting to quality and condition of the road. Cindy said that she would ask Jon to send the letter to Jeff.

Property Maintenance Ordinance- Steve said the he and John spent over an hour this morning going over Mr. Crapp's letter. He said it was a well- designed and articulate letter.

Several items prompted a slight change, which John will go over. Most of them, he either didn't read far enough or get the understanding of why it has to be the way it is. John said that he and Steve went through it also with the notes that he had taken during the last three meetings. John went through the document with the changes.
